You may also file a Petition for an Injunction for Protection at the West Regional Courthouse located at 100 North Pine Island Road, Plantation, FL 33324, Room 180. The phone numbers are 954-831-5612 and 954-831-3570.

The West Regional Courthouse is open **Monday through Friday from 8:00 AM to 4:30 PM | PLEASE NOTE** All filings after 2:00 PM must be filed at the Broward County Central Courthouse or through the eFiling Portal.

LEGAL REMEDIES THAT MAY BE AVAILABLE TO YOU THROUGH AN INJUNCTION FOR PROTECTION

- If you are granted a Temporary Injunction for Protection (restraining order) or an Order Setting a Hearing on Petition, a hearing will be set, within 15 days, to appear in front of the Judge.
- · You should come to Coast to Coast Legal Aid of South Florida for help as soon as you are granted a Temporary Injunction or an Order Setting Hearing.
- At the hearing, the Judge may grant you a Final Judgment of Injunction and extend the Injunction for a certain amount of time or until further order of court.
- If a Final Judgment of Injunction is granted, you may ask the Court for a time-sharing schedule, child support, and possession of your home. You may also ask for the Court to order treatment, classes, and/or counseling.

FREE LEGAL HELP FOR VICTIMS OF DOMESTIC VIOLENCE.

Coast to Coast Legal Aid of South Florida may be able to assist you with your family law problem, divorce, paternity case, injuction for protection/restraining order, or other civil legal matter.

If you believe you are a victim of domestic violence and need legal help with non-emergency matters, come to our office Monday -Friday, 9:00 AM to 4:00 PM.

To qualify for assistance you:

- · must be a victim of domestic violence
- must live in Broward County
- · may be required to meet certain income guidelines for divorce, iniunctions for protection, and other family law problems
